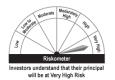

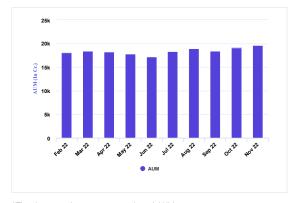

AUM Movement

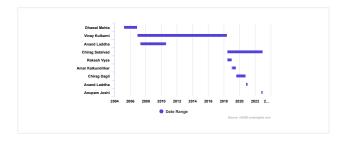


*The above graph represents month-end AUM

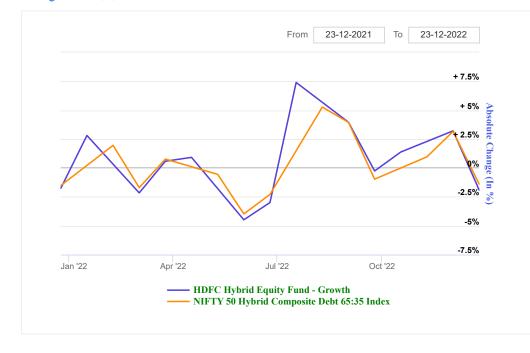

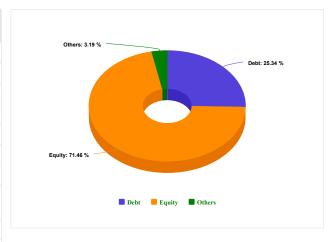

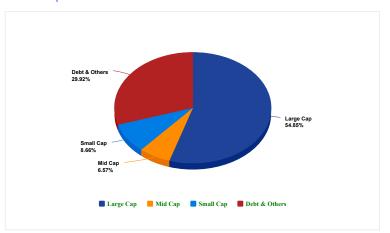

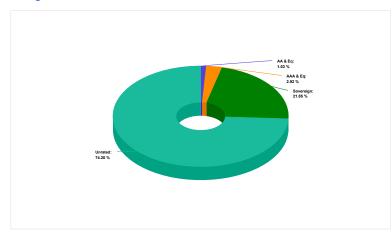
